**Junior Registration Information**  
**Sessions START the week of October 4, 2010; CONCLUDE the week of March 14, 2011.**

Skaters must register for the sessions by September 03, 2010.

Payment(s) MUST accompany application and may be made as follows:

- a) Full payment (1 year) cheque post-dated October 5, 2010
- b) Payments of 4 (four) cheques post-dated as follows:  
Cheque #1 (25% of total) September 30, 2010, Cheque #2 (25% of total) October 29, 2010 (Covering October – December);  
Cheque #3 (25% of total) November 30, 2010, Cheque #4 (25% of total) January 30, 2011 (Covering January – March)
- c) Other payment plans are available upon request.

Priority policy for allocation of spaces in StarSkate Program:

1. Skater must be registered and the fees paid.
2. The skater must be a club member.
3. The skater with the higher number of days selected will be given the first choice.
4. The skater with the higher test level will be considered first.

*Priority will be to the "home" club skaters up to the closing date for registration. The attached schedule is provisional, and will be finalized only once actual numbers of registered skaters are known. The club reserves the right to move, cancel or combine sessions if insufficient numbers of skaters register.*

There will be NO Winter Registration held! This is a 24-week program. Spaces that are not filled for the sessions by September 03, 2010 will become available to skaters from other clubs who wish to register as non-members. Priority policy does not apply to Club skaters who register after September 03, 2010.

### **Session Qualifications**

**JUNIOR:** Must be completed Stage 4 of the CanSkate Program but no higher than Senior Bronze Freeskate test and have a private coach. There are four Junior sessions offered each week. These sessions are designed for practice and private lessons. Skaters that have achieved their Junior Bronze Freeskate may also register for the Sunday Extra Freeskate. This is a 24-week program.

**SENIOR:** Must have passed the Senior Bronze Freeskate Test.

### **Skating Up or Down for Boarderline Skaters**

Skaters must register for the session they qualify for and submit a request with their registration. This will be considered and reviewed on a case-by-case basis by the junior/senior committee and their recommendation will be approved at the following monthly Board meeting preceding the start of the next skating season. If permitted, the number of skaters allowed to skate up or down shall be restricted to those within one test level of the stated requirement and be limited by the number of qualified skaters registered on the session. Late applications will not be accepted. Applicants will be contacted by the junior/senior committee to finalize their registration status. If the Board receives any legitimate complaints regarding any skater permitted to skate up or down, the Board may remove the skater from the session. Decisions by the Board are final and shall apply to the current skating season only.

### **Switching Sessions**

Skaters will only be permitted to skate on the session days they register for. Switching session days is not permitted unless a permanent change is made to the skaters registration at the club office and is subject to space availability.

### **Program Assistant Policy**

The requirement for older skaters to act as a program assistant is due to the fact that the costs for the Junior and Senior program are only partially defrayed by registration costs. Assisting in CanSkate sessions allows the club to run a comprehensive program and provide support to StarSkate Program. \*If an eligible skater is unable to fulfill the Program Assistant responsibilities, please contact the club for the unsubsidized registration fees.

### **Program Assistants Policy**

Jr./Sr. Skaters who are 12 years of age or older are REQUIRED to be a Program Assistant within our CanSkate Program. Skaters registering 1-2 days are required to sign up for at least one CanSkate Session. Those registered for 3 or more days must sign up for 2 (or more) sessions. If you skate Synchro in addition to Junior/Senior, count each synchro session as one day. (Please indicate first or second choice of sessions). Note that first priority for 30 minute PreSkate sessions goes to PAs who are also assisting on full CanSkate sessions.

**All PAs must attend the PA Clinic, scheduled for Oct. 11, 2010 at Twin Rinks from 11-3pm.**

### **Refund Policy:**

All refunds are subject to a minimum non-refundable administrative fee of \$20 and Skate Canada Fee of \$30.00. No refunds will be issued after the first day of each session.

### **Child Fitness Tax Receipts**
